I did attend the last meeting of LARA in September when the main item of interest was the VNUK case which has recently been highlighted by in particular MIA and MSA imploring people to tender their thoughts before the cutoff date for comments and objections of 31 October. I have heard nothing more but obviously the matter has not gone away with the EU going to decide what action if any to take on the matter. Contrary to what was said earlier any change following Brexit is unlikely since many of the insurance arrangements in place are pan-European and therefore would apply whether we are in or out of Europe. The FIA and FIM got involved rather late in the day when it became obvious that the VNUK case had not been forgotten about as many would have hoped, so we await the outcome.

The only other matter was the possible application by an offshoot of the Green Lane Association, All Terrain UK since they have a more modern approach to the use of off road tracks. They do seem to be responsible though and admitted to only applying to join LARA to use their expertise and knowledge of off road matters much like we do as an association so I don't see why some of the other established members were objecting. Under new chairmanship LARA does seem to have got a better grip on finances and is relatively stable at the moment. That's all
