**Rallies Committee-** Looking at BARS for navigators to become compulsory. The road opening procedure and running order are under review. Clubs hosting multi-venue stage events are required to sign the Rally Charter.

### **e) Autotest/Autosolo**

Consultation regarding a proposed reduction in minimum age is underway.

### **f) Sprint/Hillclimb**

Published changes to the National Competition Rules (NCR's) have not been highlighted in red text. Paul Goodman and John Harden stated that under the latest NCR, Junior Sprint and Hill Climb Drivers may compete in a 'Standard Car of no more than 110bhp maximum power output.' Previous regulations referred to 1400 CC. It is not clear how eligibility will be assessed.

Paul Goodman also reported that MGCC have lost their anniversary date at Anglesey circuit to a race event that pays more money. Future sprint championships will be further depleted as BRSCC and BARC are also cutting back on the number of events held each year.

## 2024.52 – Championships

Dave Thomas reported that 81 clubs have paid their subscription for 2025. Dave Thomas thanked those clubs for renewing their registration with ANWCC. There were 305 registered competitors for 2024.

The 2025 championship regulations have been drafted and the permit application submitted. Dave Thomas reported that he had difficulty completing some permits application forms in adobe format. There were errors with the functionality and inconsistencies across the different forms. It was agreed that a common approach is needed by MSUK for championship permits applications. Dave also reported that he had struggled to translate the old championship regulations into the new NCR template. Motorsport UK have yet to publish the reference table conversion reference table.

Dave is considering a number of changes to the speed championship to deal with special classes.

Paul Goodman stated that he had not yet received an invitation to apply for a speed championship permit. Paul also encouraged all delegates to watch the MSUK Club Renewal webinar available at [https://www.youtube.com/watch?v=XnGe6\\_ZSDWc](https://www.youtube.com/watch?v=XnGe6_ZSDWc).

Marshals Monthly £25 Prize Draw-the winners were:

Mark Wilkinson congratulated the winners of the prize draw. Dave Thomas asked clubs to promote the marshal championship at their events. Paul Goodman suggested that the monthly price fund for the Marshal Prize draw should be increased from £25 to £30 per month. It was agreed that ANWCC will underwrite any prize fund shortfall to ensure we maintain a minimum £500 prize fund for the end of year award. This increase was proposed by Dave Thomas and seconded by John Hardman and is effective January 2025.

## 2024.53 - Press

Maurice Ellison reported that the December 2024 copy will be his last edition of Spotlight. Katy Mashiter reported that funding for 2025 had yet to be announced. Katy stated that there may be an opportunity to run a marshal training event and alongside a promotional event to thank current volunteers and attract new marshals to the sport.

Oz Phillips introduced himself as the new British Motorsport Marshals Club Chairman for the North West. He is keen to address any disconnect between track, rally and other motorsport. BMMC marshals training will take place at Oulton Park 8/9 February 2025. Oz agreed to liaise with Katy Mashiter and extend an invitation to none-race marshals as appropriate. There may also be an opportunity to collaborate with the British Rally Marshals Club (BRMC) to host an event in the north-west. Jim Spencer has a number ANWCC promotional items.
